







## Cuba's Furthermost Points among Tourists' Options

HAVANA.- Travels to Cuba in 2025 bring higher demands among regular foreign visitors, who are eager to have an in depth knowledge of the island's environment, particularly its furthermost points.

Such objectives go hand in hand with nature, adventure and rural tourism, which demands better planning by travel agencies such as Ecotur, an entity that is happy to provide tailor-made trips.

Traveling around Cuba is a major attraction, especially because of the island's perfect sites for adventure and nature trips, which can be fully enjoyed at the country's furthermost points, real wonders in all respects.

The Cuban archipelago is composed of two main islands - Cuba and Isla de la Juventud, previously known as Isla de Pinos – and over four thousand small islands, islets and keys, many of which are an attraction for active holidays. The Cuban Island is the largest in the Caribbean, with 104,945 square kilometers, while Isla de la Juventud covers an area of 2,200 square kilometers.



Even though the wonders of the island have been promoted in the world, there are still some hardlyknown sites that allow a perfect knowledge of the insular geography, particularly the country's furthermost points, which are part of that geography people compare to a green alligator, because of the island's colorful vegetation and the archipelago's own Cuba's furthermost points include Punta Francés, in the Hicacos Peninsula, in the north; Punta del Inglés, in Cabo Cruz, in the south; Punta de Maisí, in the east, and Cabo de San Antonio, in the west.

The Hicacos Peninsula, the northernmost point, is famous for being the home of Cuba's most important resort, Varadero, which is about 140 kilometers east of Havana, the capital city, while Cabo Cruz, in the Granma province (southeast region), is the seat of important archaeological sites, such as Atabey.

Cabo Cruz is also the home of a fishermen community, where a lighthouse and tourist facilities can be found and whose unquestionable beauty can be enjoyed as part of trail trips.

Meanwhile, Cabo de San Antonio, Cuba's westernmost point, is located in the Pinar del Río province, a region that is famous for the excellent tobacco leaves used in the production of the Habanos or Cuban cigars.

However, the sea prevails in San Antonio, where the Roncali Lighthouse built by the Spanish crown on the coastal reef and which is still active today illuminates the area, until the Yucatán strait.

Punta de Maisí, in Baracoa municipality – the first village the Spanish founded in Cuba, in 1511 and which is part of Guantánamo province – is the easternmost point.

Maisí limits to the east with the Paso de Los Vientos; to the west with the Consejo Popular Sabana; to the north with the Atlantic ocean, and to the south with the Caribbean sea. A navigation lighthouse is its distinctive element.

# Support of the Revolution on International Workers Day

HAVANA.- Cuba expressed support of Socialism and the Revolution during the mass rallies held on May 1, International Workers Day, in squares and public spaces, despite the complex economic situation the country faces.

Cuban flags and posters on the proletarian party adorned the mass demonstrations that brought students, professionals, workers, families and solidarity groups together throughout the Caribbean nation. The return of the traditional march to the José Martí Revolution Square, in the capital city – interrupted by the COVID-19 pandemic – enhanced national celebrations because of the symbolism of the site, as exactly 25 years ago (May 1, 2000), historical leader Fidel Castro stated the concept of Revolution.

In the presence of the country's top leaders, tens of thousands of residents of the capital and over one thousand foreign guests stated their rejection of the blockade imposed by the United States, which has affected the lives of millions of Cubans for over six decades.

In this scenario, general secretary of the Cuban Central Trade Union (CTC) Ulises Guilarte de Nacimiento highlighted the heroism of the people and urged the working class to be involved in the country's economic recovery by making a good use of the working day and increasing lines linked to food exports and production.

He also urged the trade union movement to continue promoting industrial production, based on the availability of raw materials, and to boost the materialization of investments in the hydraulic sector, in addition to the diversification of agricultural lines, among others.

That day, mass demonstrations were held all over the island in support of the revolutionary process, encouraged from previous days under the communication campaign Por Cuba Juntos Creamos (For Cuba Together We Create), promoted by Cuban trade unionists.

Workers and trade union leaders' life stories were spread in traditional and virtual spaces, promotional spots, television and radio, in addition to interviews with representatives of various unions who gave their testimonies in relation to workers' mobilizing force.

The participation of workers in mass voluntary activities, including the revitalization of their artistic and sports movement, which systematically calls for the practice of activities in these fields, also stood out.

International Workers Day brought together in the Caribbean island more than one thousand international delegates from over 30 countries, in representation of over one hundred trade union organizations from all five continents, who condemned the economic, commercial and financial siege that prevents the full development of Cuba's productive forces.

As a culmination of the activities, the International Meeting of Solidarity with Cuba was held from April 30 to May 2, sponsored by the CTC and the Cuban Institute of Friendship with the Peoples, which led to the holding in this capital of the so-called "union tribune" and "international trade union solidarity party."

# Cuba Defends Value of Medical Missions

HAVANA.- A Cuban medical brigade was first established is May 23, 1963, when doctors were sent to Algeria, despite having sent over 50 health professionals to help recovery actions in Chile, after the Valdivia earthquake, in 1960.

It happened shortly after the mass exodus of doctors because of France's withdrawal from that African nation.

Cuba's international medical collaboration, which according to national authorities gathers the spirit of altruism and the solidarity vocation of its people, has taken on another dimension since the triumph of the Revolution in 1959, a turning point in the country's medical sector because of the migration of over half of the 6,286 professionals in service at the time.

From that month of May, in particular, Cuban doctors, paramedics, technologists and other specialists began to arrive in all the geographies of the world, especially in those places where other doctors and paramedics could not go or simply refused to go.

As the foundation of that practice states, Cuba does not use its medical growth as a diplomatic weapon nor a means of political proselytism nor an incentive for commercial relations or sale of services.

Health authorities affirm that the medical collaboration is offered expecting nothing in return, governed by purposes such as meeting the needs of recipient countries, promoting true integration, strengthening infrastructures that help health systems' sustainable growth and

benefiting populations settled in remote or overlooked areas.

Ethics, humanism, altruism, support, generosity, nobility and other values fill the luggage of the collaborators who, by the hundreds of thousands, provide their services in more than one hundred nations in Africa, America, Asia and also Europe.

Along with collaboration, Cuba promotes the training of doctors, nurses and professionals in other specialties with the opening of educational centers in almost every nation in which their brigades offer their services, and welcomes and prepares youngsters from different countries in undergraduate and postgraduate programs.

The phases of medical collaboration, its increase and diversification, fill dozens of pages and are the object of research work and newspaper articles, most of which are full of praise and testimonies revealing their scope.

However, some texts and politicians accuse the Cuban government of enslaving health professionals and getting rich with their work and talent, among other arguments that try to discredit the nature of the Cuban medical collaboration.

Against this, the voices of President Miguel Díaz-Canel; head of Parliament Esteban Lazo; Minister of Foreign Affairs Bruno Rodríguez, and other Cuban government and party leaders, resound in national and international forums.

Their voices are joined by the opinions and criteria of personalities and politicians from many countries and organizations, such as CARICOM, CELAC and ALBA-TCP



# Fidel Castro's Historic Visit to Washington

WASHINGTON.- Sixty-six years after the historic visit leader of the Revolution Fidel Castro paid to the U.S. capital, a group of children and adolescents from the Cuban Embassy retraced his steps in this city.

The initiative of the Cuban diplomatic representation will allow having an indepth knowledge of an important chapter of the national history and is part of the comprehensive program of activities for the celebrations of the centenary of Fidel's birthday, on August 13, 2026.

That day of April 15, 1959, dressed in his legendary olive-green uniform, Fidel arrived in a direct flight from Havana on-board the Brittania Libertad plane, a turboprop of the Cubana de Aviación Company and from the airport, he went to the Cuban Embassy in downtown 16th Street, in the Adams Morgan neighborhood.

The route started at the diplomatic representation, where photographs of that visit are kept, and continued along the very street up to the Meridian Hill Park (Malcolm X Park), the place that allowed the Commander in Chief to meet the residents of Washington DC on two occasions.

It is said that hundreds of supporters gathered on the other side of the street when he arrived at the Embassy that night. He was suggested to greet the people from a balcony but he said: I am not a balcony man, and decided to have direct contact with the people.

When refusing to follow the rules, he resolutely said: Enough protocols!...Of what I can and cannot do. It will happen

that landing in the United States is more difficult that the Granma landing.


Digital medias' reviews of the city indicate that "the Malcolm X Park welcomed the visit of numerous incredible historical personalities of the time, but one of the most amazing was no doubt Cuba's revolutionary leader Fidel Castro."

"Just a couple of months after heading a successful revolution in Cuba, in 1959, Castro

started his visit (...) to the United States. The American Society of Magazine Editors invited him to speak at the National Press Club and a crowd of supporters gathered at the airport," texts say. Precisely there, children made a stop. Fidel's trip (until April 20) included the Lincoln and Jefferson memorials, to lay down wreaths. Those sites were also toured by representatives of the younger generations. Then, they went to the Capitol, the seat of

the Congress, where Fidel met senators and vice-president Richard Nixon.

Fidel was in Washington DC. His spirit is still an inspiration. The date, more than ever, is still engraved in collective memory, because it endorses "the history of the right a small nation has to speak with its own voice," as the title of an article written by Ramón Sánchez Parodi, the first head of the Cuban Interest Section in the United States (1977-1989), reads.



## Monstrosity of a Wrongly-Called Act

WASHINGTON.- Under Title III of the Helms-Burton Act, a U.S. federal court gave its first verdict in a jury trial on alleged properties nationalized in Cuba after January 1, 1959.

The ruling demands the Expedia Group corporation to pay 29.8 million dollars to U.S. citizen (since 1983) Mario Echeverría, who claims the ownership of Cayo Coco, the fourth largest island of the Cuban archipelago, with 370 square kilometers and 22 kilometers of beach.

According to the plaintiff, that site, located on the northern coast of the national geography that is part of the Jardines del Rey archipelago and the central province of Ciego de Ávila, and one of Cuba's tourist destinations, is the object of an alleged improper use of properties that belonged to his family.

The suit filed against the Expedia Group as head company of Hotel.com LP, Hotels.com GP and Orbitz LLC, argues that all four entities made bookings from their digital platforms in hotels built on a land nationalized by the revolutionary government during the Second Agrarian Reform Law, in 1963.

The jury's decision determined to impose a compensatory sum of \$9.95 million dollars on each entity for damages, resulting in the total amount of \$29.85 million.

According to the legal document, the entities involved in the alleged trafficking of properties are the Iberostar Mojito, Iberostar Colonial and Pullman Cayo Coco hotels, for which compensation for damages was requested.

Federal Judge Federico Moreno, who presided over the case, wrote that "the defendant entities profited by offering bookings to customers at these hotels on their travel websites. The defendants admit that they failed to investigate whether the hotels were on confiscated land"

Expedia Group, which is headquartered in Seattle, Washington, is one of the world's largest online travel platforms, with offices in more than thirty countries. The extraterritorial Helms-Burton Act was enacted under the administration of William Clinton in 1996, but when it was signed, Title III was paused – which Donald Trump activated in May 2019 in his first term (2017-2021).

On January 14, six days before the end of his term, the then president Joe Biden chose to suspend Title III, which Trump reversed when he took up his post for his second term in the White House on January 20.

Since the activation of Title III, six years ago, 45 lawsuits have been filed, with six out-of-court settlements and a single jury verdict. Two cases are still pending at the Supreme Court.

Cuban lawyer Rodolfo Dávalos described that "as all that monstrosity which is wrongly called an Act (and nothing more and nothing less than 'For Freedom'), Title III of the Helms-Burton is absolutely illegal, not only in terms of the international law, but also in relation to constitutional, procedural and international judicial matters."

## Data Science, Endless Paths Made by Women

HAVANA.- Data is a passion for everyone in the world and knowing their exact uses and how to apply them in the future in the most varied spheres is the path chosen by six Cuban girls who are passionate about science, technology and information.

A few days after the holding of the International Girls in ICTs Day, the stories of these future scientists show that being a majority in the sector is no longer a challenge in Cuba.

Love for mathematics seems to be the common denominator of these six girls, who see in Data Science the opportunity to predict diseases, boost the growth of any company, develop Artificial Intelligence applications and take the digital future to other levels.

As Amalia González, a second-year student, told The Havana Reporter, when she entered the Mathematics career at the University of Havana she had researched the subject, but "here they make you fall in love much more with all the projects we do; and it's incredible because we can do data science in any sphere of life."

You have an idea and you wonder how you could get the data; it is not easy, it takes a lot of work and in the career, they teach us how to clean that data, to process it to make the analysis we want or they ask us to do, and to look for information.

When asked how she sees herself in the next five years, González said that in a world in which we have more and more information and everything is digitized, she visualizes herself working in the branch of business marketing or fashion.

This question was the main topic of the interviews and all the girls seem to put their data in different until I got here," she commented.



fields, which is good for science. This is the case of Cristina Hernández, who seems to be inclined towards medicine or the business area. Hernández, who is also a second-year student, came to Data Science in a very particular way: through a Korean entertainment

"Before I had vocational information, I watched a series in which the protagonist was a data scientist, and then I began to be very interested in what she did; but I didn't even know the name of the career. When this discipline was included in the university allocation plan, I had the option of applying to it, then I started to research more

According to these young girls, Data Science has a large field of work, because from any information or based on the form this is stored and can be used to work, make analyses, predictions, statistics, behaviors of any cycle of something that has happened and even predict how it could happen in the future.

"Even in the area of medicine, with machine learning, we can apply it, for example, in image processing. We worked on a project linked to dermatology, in which we processed skin spots; and from all the data available, it is possible to train the computer to learn what type of disease it is and whether it is malignant or not," Hernández explained.

## Sharing Know-How... from Italy to Cuba

HAVANA.- Italian surgeon and professor Gabriele Antonini, an expert in penile prosthesis implants, shared his practical and theoretical experience in Cuba, where he made four operations of this type together with Cuban doctors.

Antonini presented the technique applied to the treatment of erectile dysfunction and Peyronie's disease at the Cira García Central Clinic Urology-Andrology Symposium and the theoretical event of the Advanced Course on the three-component hydraulic penile prosthesis implant.

A leading surgeon in the Italian field of Andrology, Antonini arrived in this capital in March to participate in the event and perform the aforementioned operations on Cuban patients to whom penile prosthesis of three-component hydraulic system – two cylinders, a small tank and an activation mechanism – were placed.

"This system is completely invisible because it is inside the body and allows an erection whose texture and appearance cannot be distinguished from the natural one and replaces the erection system with

a mechanism that uses a physiological solution instead of blood," he said.

Penile prosthesis implants of this type also have two cylinders inserted into the penis' cavernous body, with a control device inside the scrotum and a fluid reservoir placed near the bladder.

All the elements of the prosthesis are placed inside the human body, as part of a minimally invasive surgical act through an incision at the base of the penis, no larger than two centimeters, through which the components are introduced.



This novel method allows for minimal risks of infection and a rapid recovery of the patient, approximately 15 days to resume their working life and 40 to resume their sex life.

Antonini spoke to The Havana Reporter about the high professional value of Cuban doctors and stressed the possibility of placing these Turkish-origin prostheses instead of those made in the United States, which allows carrying out operations in the face of the challenges imposed by the U.S. blockade on the island.

He also affirmed that the objective is to prepare young urologists from Cuba and other countries who study here to perform these procedures on more patients.

"We also want to begin expanding treatment to other patients from Latin America who can come to Cuba to be treated in prestigious medical institutions such as the Cira García international clinic, in which we already have several years of joint work," he said.

According to Antonini's previous explanations, prosthetic implantation stops a process of erectile dysfunction that causes a visible and irreversible shortening of the penis because of poor oxygenation of cavernous bodies.

## Is China Ready for the Tax War with the U.S.?

BEIJING.- The trade war with the United States in 2018, during Donald Trump's first term, took China by surprise, but now that tariffs have reached 145 percent, what is the outlook for the Asian Giant?

Prime Minister Li Qiang stressed that Beijing is ready to face uncertainties, while acknowledging that external shocks have put some pressure on the smooth functioning of the national economy.

Escalation in the tax war unleashed by Trump has China in its sights, but the Asian Giant has responded with similar tariffs to the United States and has stressed that "China does not want confrontations, but it is not afraid to fight". Here's the current outlook: Chinese goods imported from the U.S. are subject to up to 145 percent tariffs (125 percent added in recent days and 20 percent under the fentanyl excuse), while all goods from the U.S. face 125 percent upon arrival here.

China's Trade Ministry added 12 additional U.S. companies to the export control list and filed a lawsuit under the dispute settlement mechanism of the World Trade Organization (WTO) in relation to the latest tariff measures. "There are no winners in a trade war, protectionism has



no future," the Chinese government said, while stressing that if Washington insists on its hegemonic approach and wishes to wage a tariff war "or any other type of war," China "will go on until the end."

According to President Xi Jinping, it is normal to have differences between two different systems; however, he pointed out that there is a high complementarity between the two economies and that the successes of one should not be seen as a threat to the other one.

China's Trade Ministry affirmed that the door is open to dialogue, but if the United States really wants to negotiate, it must do so with respect and equal treatment.

#### WHILE NEGOTIATIONS ARRIVE...

In a meeting with business leaders and experts from the Asian Giant, the prime minister stressed the importance of strengthening trust, working in favor of unity and focusing on internal issues to turn crisis into opportunities.

He affirmed that this will allow promoting constant and long-term economic development in the country and stressed the need of implementing more active and effective macroeconomic policies to address external uncertainties.

Li stated that it is critical to expand and strengthen the domestic cycle and give priority to the domestic demand expansion as a long-term strategy, and proposed increasing efforts to stabilize employment, boost income growth and unleash the consumption potential of services.

He also referred to the importance of promoting the integration of scientific and technological innovation with industrial innovation to lead the demand with a high-quality offer.

HAVANA.-The Ministry of Higher Education (MES) guarantees all Cuban students the opportunity to freely access a university career or a higher technical program through new proposals.

For the academic year that will start next September, over 100,000 positions will be offered in three academic modalities: fulltime course, part-time course and distance learning.

General director of MES undergraduate formation, Deysi Fraga, commented that the ministry makes stronger efforts and strengthens measures so that more and more youngsters who finish high school enroll the country's universities.

Fraga explained that all MES-attached institutions work in the comprehensive formation of professionals in different fields, so that these can in turn act as agents of change in the country's economic and social transformations, making progress towards sustainable development.

Meanwhile, MES national director for registration and job assignment, René Sánchez, affirmed that all those who want to access a university career can do so.

He added that at present, in addition to applying to a higher level through entrance examinations, students can also directly access a university place by academic merits and through direct ways for talents. Another form of direct access is offered to students enrolled in the so-called university colleges, a modality in place in the country for over 10 years now that has reached outstanding results.

Entrance examinations, in the subjects of Spanish, math and history, will be

conducted on May 6, 9 and 13, respectively (first summon), and 23, 25 and 27 (second summon) for those unable to attend the first summon





# Centenarian Railroad Building under Maintenance

CIEGO DE ÁVILA.-The Morón railroad station, an emblematic building that is over 100 years old and was granted the National Conservation Award in 2010, is undergoing general maintenance.

Located at the north of this central Cuban province and considered the second largest railroad building founded in Cuba at the beginning of the 20th century, is included among the identity symbols of the Morón municipality, in Ciego de Ávila, for its majestic features and architectural beauty.

Transportation representative at the province, Olga Gener, explained that several parts of the building are in a very poor state because of the effects of weather phenomena, the invasion of migratory birds and the absence of maintenance.

The official commented that the main restoration actions are headed by a specialized brigade from the Camagüey province, as this is an old building and needs very specific details.

At present, work is conducted on the repair of the roof, which is one of the most damaged areas and whose tiles are removed, as well as the most rotten wood pieces.

The Morón railroad station has an important national patrimonial value, since its original design was conceived under the influence of the architecture from the south of the United States, including elements of French carpentry and majestic columns, among others

The building has a smooth clay tile hip roof and two levels with openings framed in semicircular arches, which support the original structure of the construction time, including the carpentry.

It also has historical value for being the stage of one of the largest strikes that occurred in 1925 against the Gerardo Machado dictatorship and which was led by trade union leader and head of the Cuban National Workers Confederation Enrique Varona.

## Young Talents Take Havana by Storm


For his part, Chernyshenko stated that his country would continue supporting Cuba's development efforts.

In that sense, he stressed present ties in the field of investment and energy projects; transportation; electronics; tourism; educational exchange, and agribusiness, among other sectors. Chernyshenko started his official visit to the island in the Santiago de Cuba city, a visit that took place when both nations celebrate the 65th anniversary of the restart of diplomatic relations between Cuba and the then Soviet Union.

In that eastern Cuba city, the Russian leader was welcomed by member of the Communist Party Central Committee and first Secretary in the province, Beatriz Johnson; Santiago de Cuba governor Manuel Falcón; minister of Foreign Trade and Investment Oscar Pérez-Oliva, and Russian ambassador to Cuba Victor V. Koronelli. In this city, Chernyshenko and his delegation visited

historical sites and places of interest, including the Santa Ifigenia Cemetery, where the mortal remains of several heroes and famous personalities of the Cuban culture and history lie, such as National Hero José Martí and leader of the Cuban Revolution Fidel Castro.

During his stay in Cuba, the Russian Vice-President was welcomed by Cuban president Miguel Díaz-Canel. Official sources indicated that dialogue between both leaders showed the intensity of strategic ties between both nations and highlighted opportunities to continue consolidating relations in all field.

There are also beach services, including boat and water sports equipment rentals such as bicycles and kayaks, and a gastronomy featuring seafood and fish as the main dishes of the house.




Experts consider it one of the most beautiful and virgin beaches in western Cuba.



















# Latin America Collective Challenges

TEGUCIGALPA.- The IX presidential Summit of the Community of Latin American and Caribbean States (CELAC), recently held in Honduras, showed its leaders' strong commitment to the region's unity and the defense of multilateralism.

Under the leadership, for the past year, of president Xiomara Castro, the region's largest integration bloc emerged stronger from the Tegucigalpa meeting, determined

to face the complex international scenario with common actions.

In her capacity as CELAC pro-tempore president, Castro managed to make the body stand out with stronger force in light of the difficult dynamics of today's global economic and geopolitical reordering.

At the opening of the event, that gathered 11 presidents, 20 foreign affairs ministers and representatives of the Community's 33 member nations, Honduras's first woman president urged to discuss the new international order the United States is imposing, as she denounced.

In this sense, she also urged the bloc to put the new world order the administration of Donald Trump tries to impose with its tax measures and its policy of mass deportations of Latin American and Caribbean immigrants at the center of the discussions.

We cannot continue walking separately when the world is reorganizing itself without us, but we cannot come together either by repeating failed recipes of the past, said the head of State, who passed the pro-tempore presidency of the CELAC to his Colombian peer, Gustavo Petro.

When evaluating the work conducted during the year she was at the head of this intergovernmental mechanism, born 15 years ago, Castro affirmed that the bloc grew stronger with numerous initiatives, for the wellbeing of our peoples.

"CELAC is not a perfect organization, but it is ours; it is born from a dream, an ideal and a utopia of our liberators and heroes," she stressed.

In her speech, the president denounced "the cruel and inhumane blockade the United States has imposed on the heroic people of Cuba for over 64 years" and demanded the international community

to stop aggression against the Palestinian people.

"Cuba does not export terrorists; it exports teachers, scientists, doctors and the dignity our peoples demand," she said.

The IX Summit concluded with the approval of the Tegucigalpa Declaration, the main document emanating from these annual meetings.

In its resolution, adopted by "enough consensus," 30 of the 33 member states endorsed their commitment to the strengthening of CELAC as the continent's main mechanism of political association.

At the closing of the event, Honduran foreign affairs minister Enrique Reina highlighted the consensus reached in key topics such as full validity of the Proclamation of Latin America and the Caribbean as a Peace Zone, 11 years after the signing of that text in Havana, Cuba. He also made reference to protection and promotion of all human rights; respect to self-determination; non-interference in domestic issues; sovereignty and territorial integrity, the document reads.

Participants categorically challenged the imposition of unilateral coercive measures that contravene the international right, particularly those that affect developing countries' trade and economy.





# Energy, Climate Crisis and Digital Colonialism

HAVANA.- Experts affirm that the world makes rapid progress towards the era of electricity and artificial intelligence (AI), while 680 million people live without electricity in their homes.


The International Energy Agency (IEA) confirmed that energy demand in the world rose by 2.2 percent in 2024, lower than the gross domestic product (GDP) growth of 3.2 percent but above the average annual demand increase of 1.3 percent from 2013 to 2023.

Acceleration in energy demand was led by electricity consumption, with nearly 1,100 additional terawatt-hours, which represented an increase of over 4.3 percent in comparison to the previous year, according to a study published in March 2025.

Such rise was mainly driven by high temperatures that boosted demand for cooling in many countries, as well as by the growth of digital data centers and AI, industrial consumption and electrification of transport.

In spite of opposing opinions and uncertainties, there is one clear fact: "electricity use is growing rapidly, pulling overall energy demand along with it," said IEA Executive Director Fatih Birol.

Meanwhile, the International Renewable Energy Agency (IRENA) estimated that the use of clean sources guaranteed over 90 percent of the electricity capacity



expansion in 2024, although notable geographical asymmetries and failures to meet climate agreements remained in place.

With 585 gigawatts (GW) of capacity additions, the sub-sector reached 4,448 GW last year, which was another global benchmark, although progress still falls

short of the 11.2 terawatts needed to align with the global goal to triple installed renewable energy capacity by 2030.

Most of the increase occurred in Asia, with the greatest share being contributed by China, with almost 64 percent of the global added capacity.

According to IRENA director general, Francesco La Camera, evidence shows that renewable energies are economically viable and "readily deployable."

Each year, they keep breaking their own expansion records, "but we also face the same challenges of great regional disparities and the ticking clock as the 2030 deadline is imminent," he regretted. Energy burning represents over three quarters of the greenhouse gas emissions; thus, financing energy efficient initiatives and applying large scale renewable energies are essential, in spite of the ups and downs of climate.

Humanity is heading towards a future in which electricity, especially from renewable sources, will be essential, as according to estimates, AI and cryptocoins could double energy consumption in data centers by 2026 – which will exceed one thousand terawatt-hours.

As industrialized powers discuss how to regulate AI or how to avoid algorithms to be biased, priority in many parts of the world continues lying in access to basic infrastructures, including those that provide energy, to take millions of human beings out of physical and intellectual darkness.

MINCEX minister Oscar Pérez-Oliva and Foreign Trade, Foreign Investment and International Cooperation director in Santiago de Cuba, Madelaine Cortés, announced the event summon in the presence of the diplomatic corps accredited to Havana, and invited interested people to participate.

Pérez-Oliva told the press that the fair should become a new opportunity to strengthen not only regional integration but also economic and commercial association between the Greater Caribbean and other countries of the world, such as Russia, as the event's program of activities foresees a forum with that Eurasian nation.

Companies and agencies that promote trade, investment and cooperation between Africa, Asia, Europe and Latin America, are invited to participate, in addition to representations of the United Nations bodies in Cuba and other multilateral institutions, the text added.

# Important Presence

HANOI.- The presence, for the first time in more than 10 years, of a large Cuban delegation at the 34th edition of the Vietnam Expo 2025 Trade Fair was not only significant but very beneficial too.

The delegation met the objectives proposed and there is a clear atmosphere of understanding about the existence of a potential for opportunities, which will allow improving business relations between the two countries, president of the Cuban Chamber of Commerce Antonio Carricarte told **The Havana Reporter** (THR).

Being here is essential to meet new economic actors, diversify our relations and expand ties not only with the Vietnam Chamber of Commerce and Industry, but also with the diverse associative world of this Southeast Asian nation, he said.

situation mean that these are not exempt from obstacles for their materialization, he said.

The above was corroborated in dialogue with THR by vice president of the Food and Poultry Entrepreneurial Group (GEALAV), Doriel González, and Development director at the Pork Production and Marketing Entrepreneurial Group, Edelkys Núñez – both entities, attached to the Ministry of Agriculture.

## Transportation Fair Closes with Important Agreements

HAVANA.- The III edition of the Cuban International Transportation and Logistics Fair (FITL 2025) concluded with the signing of over 130 business documents, Transportation minister Eduardo Rodríguez announced. Companies from different countries met from April 1 – 3 at the PABEXPO fairground to show their products, projects and experiences, a sign of the global interest in strengthening our logistics capacities, Rodríguez affirmed at the closing of the event, in the presence of Cuban president Miguel Díaz-Canel.

Among the documents signed, contracts, memorandums and agreements are included, which will foster export and will endorse the recovery, development and gradual growth of the Cuban transportation system, the minister added.

Progress is made on the first electric busses terminal project for public transportation in Havana, as well as the acquisition of 20 new electric busses for the transportation of the aviation staff, which will also support public transport, Rodríguez commented.

These days, "we have had the pleasure of seeing how projects developed in previous editions have come true, and we are convinced that in the IV edition these will be higher," the minister said.

We know that we need to do a lot more, to make faster progress, stressed Rodríguez, who acknowledged the

pressing need for solutions to challenges, for which new ideas, paths that lead to the recovery of the transportation system in Cuba, are considered.

The minister appreciated the participants for contributing and believing in the potential of the transportation and logistics system amidst the difficult situation the country faces

At the conclusion of his speech, the head of the Transportation ministry convened the IV edition of the International Transportation and Logistics Fair, to be held in 2027.

At the present edition, whose purpose was to foster development and alliances between different actors of the economy, promote direct foreign investment and boost international cooperation, exhibitors from 16 countries presented their goods and services in 86 stands.

The University also requested him to give classes at the Department of Sports Sciences, in the track and field discipline, while joining the project of former Minister of Education Dr Lazarus Dokora, which brings physical activity to children and youngsters from several regions.

After winning the title in the Elite 16 in Quintana Roo, Mexico, the first of the high rank ProTour competitions – the rest include the Challenge and Futures tournaments – Alayo and Díaz finished fifth in the tournament of the same category in Saquarema, Brazil, where they also suffered a major setback by finishing in 19th position after losing the matches of their initial pool against the Canadian couple Samuel Schachter-Jonathan Pickett and the Swedish Jacob Holting Nilsson and Elmer Andersson

Schachter-Pickett swept the Cubans 2-0 (21-14, 21-15), with a remarkable balance in all game areas: 22 points in attack, seven in blocks, five in serve, just 7 unforced errors and 12 saves. Alayo and Díaz's balance was totally different; they were almost invisible along the net and made eight mistakes in the match.

The Cuban players' fiasco in this event was materialized against the Nordics, who won by a narrow 2-1 (19-21, 25-23, 15-11) in a match the Cubans had in their hands in the second

set, which they led by 19-17. However, an unusual poor defense (only 10 balls saved by 16 their rivals), lack of concentration at crucial moments and poor performance at the net, once again, made them lose a set that seemed to be theirs – which prevented them not only from winning but also from advancing to the next round – and to finally lose in the tie break. Their performance in Brasilia leaves them several lessons, as they now have

several weeks to recover and resume their physical and tactical preparation, after guaranteeing at least their inclusion among the top 10 in the International Volleyball Federation (FIVB) ranking – they currently occupy the eighth position with 5,820 points – which is led by Swedish Olympic champions David Ahman and Jonatan Hellvig (8,420), followed by Norwegians Anders Mol and Christian

Sorum (7,600), bronze medalists in the Paris 2024 Olympic Games.

The next stop the Cubans will have on the calendar is at home, at the opening of the NORCECA Continental Tour in the Varadero resort, held every year at the Solymar Arenas Blancas Complex. Strangely enough, this is an event they have never been able to win and will now serve as their main challenge





## About 100 Countries Confirm Participation in SPIEF 2025

MOSCOW.- About 100 countries and territories of the world, including Latin America, have confirmed their participation in the Saint Petersburg International Economic Forum (SPIEF) 2025, to be held next June.

In a press release issued at the end of April, Roscongress informed that when there were two months to go for the start of SPIEF 2025, the number of nations and territories that have confirmed their attendance is five percent higher to that of last year.

Advisor of the Russian president and executive secretary of the forum's organizing committee, Anton Kabiakov, highlighted that this year "the role of the Global South is particularly evident," while stressing the "great interest the Asian, African and Latin American countries have in the forum's agenda." He also added that the Kingdom of Bahrain, Russia's important partner in the Near East, will be the guest country at SPIEF 2025.

According to Kobiakov, the large participation of nations and the diversity of topics create unique conditions to develop practical solutions based on shared values and mutual respect.

The increase of interest and attendance to the event clearly show the forum's rising global importance as a leading platform for the forging of new economic ties in a multipolar world, he said.

The release also added that 15 bilateral business dialogues have already been arranged with partners from Armenia, Africa, Bahrain, Vietnam, the European Union, India, Kazakhstan, Kirgizstan, China, Latin America, Moldavia, Mongolia, Thailand, Uzbekistan, the Eurasian Economic Union and the Association of Southeast Asian Nations.

SPIEF, an event held in the Russian city of Saint Petersburg that this year will take place from June 18 to 21, offers a space for dialogue and business development.

The forum, whose first edition was held in 1997, is organized since 2006 under the sponsorship and with the
